## **Overall Readiness Score**







## **Prioritized Recommendations**

#### **HIGH PRIORITY**

1. **Executive Communication Enhancement:** Implement automated executive notification system with pre-defined escalation paths. Conduct quarterly tabletop exercises with C-level participation. *Timeline: 30 days | Investment: \$15K | Impact: High* 

2. **Vendor Risk Management Program:** Establish formal third-party risk assessment process with continuous monitoring. Critical for supply chain security. *Timeline:* 60 days | Investment: \$40K | Impact: High

#### **MEDIUM PRIORITY**

3. **Threat Intelligence Integration:** Deploy automated threat intelligence platform with SIEM integration for real-time threat correlation.

Timeline: 90 days | Investment: \$75K | Impact: Medium

4. **Automated Response Capabilities:** Implement SOAR platform for common incident types to reduce MTTR by 40-50%.



Timeline: 120 days | Investment: \$100K | Impact: Medium

#### **LOW PRIORITY**

5. **Security Awareness Optimization:** Expand phishing simulation program and add gamification elements to increase engagement.

Timeline: 90 days | Investment: \$20K | Impact: Low

# **Next Steps**

- 1. Review and approve prioritized recommendations with executive leadership
- 2. Allocate budget for high-priority initiatives in Q1 planning
- 3. Assign project owners and establish implementation timelines
- 4. Schedule follow-up readiness assessment in 6 months to measure progress
- 5. Conduct quarterly progress reviews with security steering committee
